1 WHEREAS, the sentencing and asset forfeiture hearing of Defendant Dr.
2 Vinod C. Patwardhan was initially set for July 20, 2009.

3 WHEREAS, defense counsel requires additional time to review and analyze
4 the Medicare claims figures referenced in the government's Sentencing Position and
5 Application for Preliminary Order of Forfeiture,¹ and therefore sought to move the
6 sentencing to mid-August.

7 WHEREAS, the government proposed, and the defense is agreeable with, a
8 sentencing and asset forfeiture hearing date of September 21, 2009 because the
9 government's forfeiture counsel is unavailable from mid-August to early September
10 on account of her travel and trial schedule.

11 IT IS HEREBY STIPULATED AND AGREED by the parties, through their
12 undersigned counsel, that, subject to the approval of the Court, Defendant's
13 sentencing and asset forfeiture hearing shall be continued to September 21, 2009 or
14 to the next date thereafter that is convenient for the Court. The parties further
15 stipulate and agree that the Defendant's oppositions to the government's Sentencing
