

NOTICE OF INTENTION TO CIRCULATE RECALL PETITION

TO THE HONORABLE MONICA GARCIA :

Pursuant to Section 11020, California Elections Code, the undersigned registered qualified voters of the CITY OF BALDWIN PARK, in the State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from office of CITY COUNCIL MEMBER in the CITY OF BALDWIN PARK, California, and to demand election of a successor in that office.

The grounds for the recall are as follows:

- A. Monica Garcia is employed by and owns stock in a developer who does work in the City. Her employer was a cause that a Lowe's store did not open, costing the city tax revenues and jobs.
- B. Monica Garcia refuses to prove that she lives in Baldwin Park, and she likely lives elsewhere.
- C. Monica Garcia voted with council majority of council to harm the police department and leave the City with less experienced officers, a police chief that has no experience and who did not meet the job's qualifications. Other qualified persons feared the hostile work environment created by the City Council majority, including Monica Garcia.
- D. Monica Garcia received campaign donations from major land developers to the tune of more than 85,000 dollars, compromising her judgment and putting the City at risk of her bad decisions.
- E. Monica Garcia fails to speak for herself at council meetings and is only a puppet of the mayor.
- F. Monica Garcia failed to keep with the campaign promises she made when she ran for election.

(b) If an answer is filed, the official shall, within seven days after the filing of the notice of intention, also serve a copy of it, by personal delivery or by certified mail, on one of the proponents named in the notice of intention.

(c) The answer shall be signed and shall be accompanied by the printed named and business or residence address of the officer sought to be recall.
