

NOTICE OF INTENTION TO CIRCULATE RECALL PETITION

TO THE HONORABLE ANTHONY BEJARANO :

Pursuant to Section 11020, California Elections Code, the undersigned registered qualified voters of the CITY OF BALDWIN PARK, in the State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from office of CITY COUNCIL MEMBER in the CITY OF BALDWIN PARK, California, and to demand election of a successor in that office.

The grounds for the recall are as follows:

- A. Anthony Bejarano stated at a City Council meeting that the police were a "luxury," and if people do not like his views on the police and redevelopment they should move to East Los Angeles.
- B. Anthony Bejarano has supported the mayor in causing havoc in the Police Department based on their requests for special favors. He has wrongly stated that police officers are "greedy" and they should work for whatever the City pays them, even though it is the lowest pay in the area. He has asked the police for special favors, including for his dad, who got in trouble with school board. He was one of the people behind illegally firing the Police Chief, costing the City \$75,000.
- C. Anthony Bejarano is more concerned about eating sushi at restaurants than taking care of the City and the problems of day laborers and public safety.
- D. Anthony Bejarano is another City Council member who will financially gain if redevelopment is approved. Bejarano recently bought a house just outside of the future eminent domain area, and Bejarano's support of redevelopment will create an improper financial gain for Bejarano himself.

(a) Within in seven days after filing of the Notice of Intention, the officer sought to be recalled may file with the elections official, or in the case of a state officer, the Secretary of State, an answer, in not more than 200 words, to the statement of the proponents.

(b) If an answer is filed, the official shall, within seven days after the filing of the notice of intention, also serve a copy of it, by personal delivery or by certified mail, on one of the proponents named in the notice of intention.

(c) The answer shall be signed and shall be accompanied by the printed named and business or residence address of the officer sought to be recall.
