

NOTICE OF INTENTION TO CIRCULATE RECALL PETITION

TO THE HONORABLE MARLEN GARCIA :

Pursuant to Section 11020, California Elections Code, the undersigned registered qualified voters of the CITY OF BALDWIN PARK, in the State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from office of CITY COUNCIL MEMBER in the CITY OF BALDWIN PARK, California, and to demand election of a successor in that office.

The grounds for the recall are as follows:

- A. Marlen Garcia has told people at City Council meetings that Baldwin Park Police are greedy, and if the citizens of Baldwin Park do not like her views to move to Tijuana.
- B. Marlen Garcia participated in voting to harm the police department. She supported the mayor's plan to run the City and the Police based on special favors for themselves. She voted to illegally fire of the chief of police at a cost to the City of \$75,000.
- C. Marlen Garcia took advantage of her inside knowledge of pending redevelopment proposals to buy a house at a location exempt from future eminent domain, and if the redevelopment plan she is pushing with her votes occurs, for her recently-acquired property's value will increase.
- D. Marlen Garcia works for a major healthcare company. She is using her votes and official power to close small medical clinics in Baldwin Park so that poor people are denied affordable and local medical care, forcing them to use her company's services, and giving it an unfair financial windfall.

(c) The answer shall be signed and shall be accompanied by the printed named and business or residence address of the officer sought to be recall.


